PARK DIRECTIONS: Raccoon Creek State Park is located in southern Beaver County, 25 miles west of Pittsburgh. From the west, follow Route 18 north from the Florence Exit of Route 22. From the east, follow Route 30 west from the Imperial Exit of Route 22. Access from the north and south is via PA Route 18.

AREA DIRECTIONS: Wildflower Reserve is located on Route 30, opposite the main park entrance.

FACILITY DIRECTIONS: From the Route 18 park entrance, follow the park road west, past the park office for 0.7 miles. At the Y intersection, bear left and continue on for 0.5 miles to the sign Raccoon Creek State Park - Family Cabins. Turn left at this point and follow the road to the crest of the hill. The Recreation Hall is the building in front of you, at the far side of the circular roadway.

PERMIT CONDITIONS FOR MEETING ROOM-- Occupants are also subject to the following permit conditions:

1. The size of the group is limited to the number permitted (see above).
2. Occupant shall include at least one person 18 years of age or older.
3. This permit may not be assigned or transferred.
4. Alcoholic Beverages are Prohibited.

VIOLATIONS: --Violation of park rules and regulations or violation of a condition of this permit could result in any or all of the following consequences:

1. The permit may be revoked. This would mean that the occupants would be required to vacate the day use facility immediately.
2. The occupants may be required to leave the park.
3. The occupants may be cited for violation of park rules and regulations, a summary offense.
4. The occupants are responsible for any loss or damage to furnishings, fixtures, equipment, or facilities that occurred during or due to their occupancy.

IMPORTANT NOTES:

Alcoholic Beverages are Prohibited. Please be aware that bringing firewood into PA is prohibited and could result in a fine or citation. Moving firewood into parks spreads insects and diseases. The use of local firewood is strongly recommended and is available from local vendors and maybe at the park. All firewood must be burned prior to your departure.
